
Land acknowledgement

We would like to take this time to express gratitude and appreciation to the Anishinaabe peoples who live on and care for this land. Land acknowledgements are a way for us to reflect on the ongoing colonial legacies of Canada and the ways in which settlers, ourselves included, continue to perpetuate and benefit from colonial violence. We acknowledge that we are hosting our Annual General Meeting on the traditional territories of the Anishinaabeg, Haudenosaunee, Attawandaron (Neutral), and Wendat peoples. Today, we have been invited to visit land on Chippewas of the Thames First Nation.


The Stoneridge venue we are in today is located within the McKee Treaty that was signed in 1790 by the Anishinaabe Nations also known as the Three Fires Confederacy that are currently located in Southwestern Ontario. We are also within Treaty 6, the London Township purchase signed in 1796 by Anishinaabe peoples and the Longwoods Treaty which was negotiated over several years from 1818 to 1822, where the sole signatories were Chippewas of the Thames leadership.

We acknowledge that Indigenous peoples worldwide had pre-existing systems of governance, education, diverse languages, economies of trade and ways of being before colonization, and that their ways of life were harmonized with the well-being of the natural environment. We acknowledge that First Nations identities pre-date colonization and the creation of treaties that have devolved entire economic and education systems, intersections of communities, languages and cultures into a delegation of reserve systems that today encompass only 0.2% of the land surface of Canada.

We are thankful for the resolve and leadership of First Nations peoples and appreciate their emotional labour of educating settlers and offering guidance on the way forward for decolonizing, unsettling and reconciliation.



Carolinian Canada as an organization continues to learn and commit to facilitating meaningful cross-cultural interactions to support environmental work, networking, movement building and peacemaking.

In essence, we are taking environmentally sensitive, marginal lands out of agricultural production and appointing them to the production of cleaner air, cleaner water, increased wildlife habitat and other ecosystem services.
